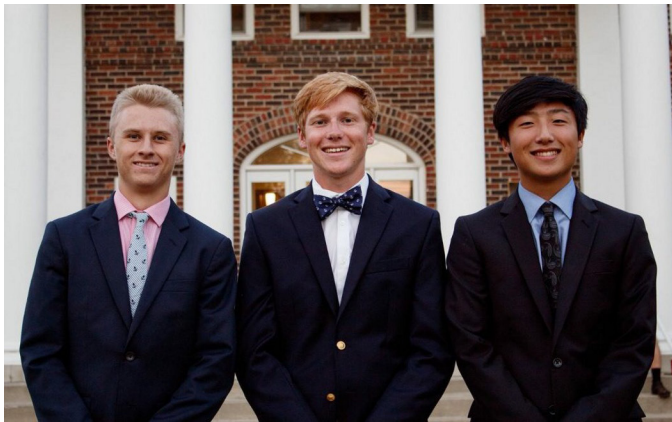

### Academics

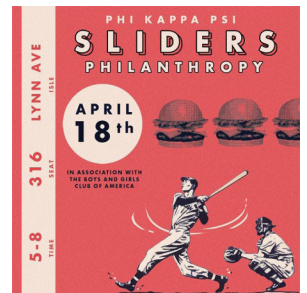
Spring semester was another good one for us academically. Our overall chapter average of 3.29 ranked us third out of 32 IFC fraternities. Of our 87 men on the spring term roster, 68 of us (78%) had a 3.00 or above, 43 of us (49%) had a 3.50 or above, and four of us — Pat Karys, Dylan Bueltel, Cody West, and Jordan Sillman — had a perfect 4.00.

### Brotherhood

This semester, our fantastic brotherhood chairs — Keegan Lass and Matthew Oberreuter — put together several events for our members to enjoy. The biggest of the events was a trip to Des Moines to watch the Iowa Wild hockey game. They also helped plan other activities, like cheering on our brothers during intramural games, and supporting Jackson Scholten and Charlie Erdman as they sang and played their guitars at open mic night at the Memorial Union's Maintenance Shop.

### Philanthropy

Our spring philanthropy went very smoothly, thanks to our Philanthropy chair Evan Smith. Our annual "Phi Psi Sliders" event supported the Boys and Girls Club of Story County, a tremendous organization with a mission to inspire all young people to reach their full potential as productive, caring, and responsible citizens. In total, the event raised \$1,846 for children in need.

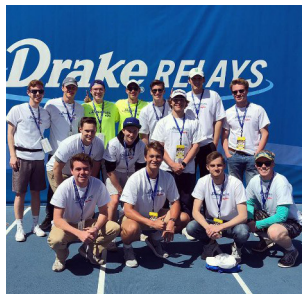

Two awards are presented each semester, one to an underclassman (first or second year of college) and one to an upperclassman (third year of college or above).

## Spotlight on: Andrew Allard, '10-1390

*Editor's Note: It is probably fair to say that most alumni never think about helping a chapter other than their own. But Andrew is not only helping Iowa Beta — by being on the House Corporation Board — he is also helping Ohio Kappa by serving on their Chapter Advisory Committee. If you'd like to get involved with a chapter, there very well may be one nearby that could use your help.*

I am from the small northwest town of Akron, Iowa. I went to Iowa State University to obtain my Construction Engineering degree. There I was involved with several activities, including VEISHA, Varieties, Yell-Like-Hell, and Lip Sync. I also took an active role within Phi Psi, holding multiple committee and officer positions including Risk Management, Finance, Governing, Treasurer, and Vice President.

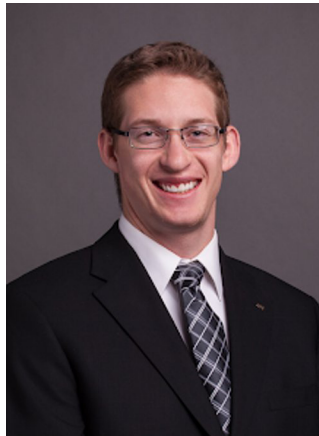
I currently live in Akron, Ohio, and work for Burns & McDonnell. My current client is in the business of transmitting and distributing electricity to over six million customers in six states. My job entails running a project from inception to completion, which can take anywhere from three to four months to as much as three to four years. This includes putting together the project team members, orchestrating financial reports, and scheduling outages on transmission lines and at substations in order to perform the work. Some highlights of my time as a project manager thus far include assisting with project management duties on a \$90,000,000 project that was just completed in May. I currently have one project of my own in the \$40,000,000 range that is now in construction and scheduled to be completed by the end of 2018. Besides these two behemoths, I also maintain a portfolio of approximately 20-30 other smaller projects at the same time.

I am from a family of five boys. I'm the oldest, followed by twins Austin and Aaron, and then Adam and Arik. The twins just completed their freshman year of college. Aaron is at Iowa State, and he just initiated into Iowa Beta this spring. Adam is our wrestler. He has already captured two state titles and is hoping for two more while pursuing his goal of wrestling at a Division 1 program in college. Arik is the youngest, but is already showing signs of becoming an elite baseball player.

My hobbies typically include playing as much golf as possible during the summer months and bowling during the winter months. I enjoy getting my friends together and lounging at the nearby lakes and watching the Indians and Cavs. Through work, I also stay involved with volunteering. I help out regularly with the local food bank, Habitat for Humanity, Soapbox Derby Car, charity golf outings, and ACCESS.

As I have previously stated, Phi Psi was my home and family at Iowa State. Within this large institution of almost 30,000 people it helped me find my best friends in life — people I wouldn't trade for the world. They are the ones who truly made my experience in college unforgettable. Phi Psi also provided me with the opportunity to grow as a person and as a leader, as I overcame numerous challenges during my four years. The pains of growing the fraternity from less than 30 to more than 75 members, and the lessons learned on the Governing Committee, gave me a simulation of life after college and taught me how important interpersonal skills and relationships are in the real world.

In the four short years since I graduated from Iowa State, I have attended six weddings (with one more to go this year), made it back for Homecoming each year, and attended a yearly



gathering of my pledge class and the classes on either side for some post-grad shenanigans as we reminisced about the "good ole times." While I may not be available day in and day out, I always try to stay connected and make it back to as many events as possible.

I got involved with the Kent State Phi Psi Colony shortly after I moved to Ohio because **Benny Rohloff, '11-1411**, had just joined the Headquarters' staff as an expansion consultant. (It just so happened that not even graduating from Iowa State could keep Benny away — inside joke!) Headquarters assigned Benny to restart the Kent State Colony, and Benny, in turn, asked if I would help by being one of the advisors on the newly created Colony Advisor Team. Of course I said yes.

The Colony has four advisors: two recent alumni, and two older alumni from the original Kent State Chapter. While Headquarters has defined roles for each advisor, I took on a mixed role of creating a culture of efficient operations. The Team has worked together to implement processes and procedures for the Colony to follow, utilizing the undergrads' input.

This was my first experience in creating a colony from the ground up. When I started at Iowa State, all of the processes were already in place, and only ongoing, minor tweaks here and there were needed. And it wasn't as though I could just copy and paste what we did at Iowa State and use it at Kent State. Headquarters has come out with multiple new requirements for colonies, and Kent State is nothing like Iowa State when it comes to University policies.

It took just under two years from the time Benny called me to talk about the advisor position, to the time the undergraduates and advisor team thought the Colony was ready for rechartering. Finally, on March 4, 2018, reinstallation of the Kent State Chapter occurred and the National President presented Ohio Kappa with its charter. (You can read about it on page 14 of the Summer 2018 issue of *The Shield*.)

Since that time, I have been focusing on working with the officer team to revise its by-laws and begin the continuous improvement cycle. The next big challenge for this group is to focus on something we have all heard from our very own Bill Good '69 — RECRUIT, RECRUIT, and RECRUIT! Due to University policies, this is still a challenge for the Kent State chapter, but I know that the guys we have will be able to move forward and find a way to continue to grow.

## Notice of Special Meeting of Members

The entity known colloquially as the "Corporation Board" or "House Corporation" is an Iowa nonprofit corporation whose legal name is "Iowa Beta of Phi Kappa Psi," (the "Corporation"), and whose members consist of all men initiated by the Iowa Beta chapter of Phi Kappa Psi.

A special meeting of the members of the Corporation will be held Wednesday, September 12, 2018 at 10:00 A.M. at the office of Board Treasurer Doug Fuller, 1001 Office Park Road, Suite 319, West Des Moines, Iowa 50265, to consider amendments to the Corporation's Articles of Incorporation.

The primary reason for the proposed changes is to have the articles reflect that the Corporation intends to operate within the parameters of Internal Revenue Code Section 501(c)(7) (applicable to social clubs) rather than Section 501(c)(2) (applicable to corporations organized to hold title to property for exempt organizations). For many years, the conventional thinking was that (c)(2) was the section most appropriate for House Corporations and our current articles reflect that. More recently, based upon various IRS rulings and court cases which have taken a restrictive view on what (c)(2) corporations are allowed to do, the thinking is that (c)(7) is the section that is more appropriate if the Corporation is going to operate the way that most such corporations have historically operated. This is the current recommendation of our National Fraternity and of national boards of other Greek organizations.

The proposed amendments are being made in the form of a restatement of the articles for two reasons: (1) to make a number of other minor changes, and (2) so that all of the articles, whether or not amended, are all reflected in one document. The articles were last restated in 1981; since then, the Iowa Nonprofit Corporation Act has been substantially revised, so the proposed restatement and amendments are intended to bring the articles current.

The proposed restatement and amendments were unanimously approved May 7, 2018, at a regular meeting of the Corporation's Board of Directors. ### AMENDED AND RESTATED ARTICLES OF INCORPORATION OF IOWA BETA OF PHI KAPPA PSI

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Subchapter X, Part 1 of the Revised Iowa Nonprofit Corporation Act ("Act"), the undersigned Corporation adopts the following Amended and Restated Articles of Incorporation:

#### Article I: Name

The name of the Corporation is Iowa Beta of Phi Kappa Psi.

#### Article II: Duration

The Corporation shall have perpetual duration.

#### Article III: Purposes, Powers

The Corporation is organized exclusively as a nonprofit corporation for the purpose of promoting the interests of the Iowa Beta Chapter of Phi Kappa Psi, a collegiate fraternity located in Ames, Iowa, within the parameters allowed under section 501(c)(7) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of the Corporation shall inure to the benefit of any member, director, or officer of the Corporation, or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes.

In furtherance of such purposes, the Corporation is authorized to exercise all powers and rights that are or may be authorized

by the laws of the State of Iowa for nonprofit corporations now or hereafter enacted.

#### Article IV: Members

The Corporation shall have one class of members consisting of all initiated members of the Iowa Beta Chapter of Phi Kappa Psi Fraternity and whose rights are as described in the bylaws.

#### Article V: Management of the Corporation

The Corporation shall be managed by a Board of Directors ("Board"), which shall have the power to adopt, alter, amend, or repeal bylaws. The bylaws may contain any provisions for the regulation and management of the Corporation not inconsistent with law or these Articles of Incorporation. Notwithstanding this general authority of the Board to manage the Corporation, no decision to sell the Corporation's real property or to dissolve the Corporation shall be made without the consent of both the Board and the members.

#### Article VI: Liability, Indemnification

A director of the Corporation shall not be liable to the Corporation or its members for money damages for any action taken, or any failure to take any action, as a director, except liability for any of the following: (1) the amount of a financial benefit received by a director to which the director is not entitled; (2) an intentional infliction of harm on the Corporation or the members; (3) a violation of the unlawful distribution provision of the Act; or (4) an intentional violation of criminal law.

The Corporation shall indemnify a director for liability (as such term is defined in section 504.851(5) of the Act) to any person for any action taken, or any failure to take any action, as a director, except for liability for any of the exceptions set forth in the previous paragraph.

Any repeal or modification of this Article shall be prospective only and shall not adversely affect any limitation on the personal liability or any other right or protection of a director, or any indemnification obligations of the Corporation, with respect to any state of facts existing at or prior to the time of such repeal or modification.

#### Article VII: Dissolution

Upon dissolution or winding up of the affairs of this Corporation, the assets remaining after payment of all expenses of such dissolution shall be distributed to a trust established by the Phi Kappa Psi Fraternity for the receipt of such assets and such assets shall be transferred to such trust; provided, however, that if the Iowa Beta chapter is reestablished within twenty-one (21) years, the corpus of such trust shall be returned to the corporation required to be organized under Article VI, Section 13, of the Bylaws of the Phi Kappa Psi Fraternity.

#### Article VIII: Amendments

These Articles may be amended from time to time as provided by Iowa law.

#### Certificate:

These Amended and Restated Articles of Incorporation: (1) contain amendments which were approved on September 12, 2018, by the members in the manner required by the Act, the articles of incorporation, and bylaws; and (2) consolidate the original articles of incorporation and all amendments into a single document and supersede the original articles of incorporation and all previous amendments thereto.

When he completed his years in the Navy, Jack returned to Des Moines to marry his high school sweetheart, Kathryn "Kaye" Nolan. They were together for over 70 years; she passed away in 2017. Jack's career was widely varied, as he loved a new challenge or a problem to solve, and he traveled all over the world. He is survived by his numerous children and grandchildren. 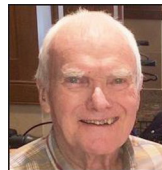

He was president of the Minnie Crippen Home, served on the Finance Committee of the Community Foundation of Northeast Iowa for 17 years, and was on the Board of Sunnyside Country Club. Bob was a longtime member of the Kiwanis, Elks, and Chamber of Commerce, and has been recognized by the University of Northern Iowa, Shattuck Military Academy, and Columbus High School for his generous support. An avid sportsman, Bob loved golf, hunting, fishing, skiing, and building and flying model airplanes. He is survived by his wife, Mary; daughters Martha Bloom, Bobbe Carney, and Amy Lichty; son John; nine grandchildren; and seven great-grandchildren.



**William H. Reinhardt, Jr., '46-428**, of Oakdale, Minnesota, died May 21, 2018, at age 91. Born in 1927, Bill served in the Navy, starting in the V12 program at Iowa State University in 1944, and graduated from ISU with a degree in Civil Engineering in 1948. He successfully founded Reinhardt Construction Company in Centralia, Missouri, in 1955, and remained "Chief" until he retired. Bill was an exemplary member of Rotary International in Woodbury and Centralia, attended 38 international conventions, and served as District Governor for District 605. He was a man of strong faith and a devoted member of The United Methodist Church in Minnesota and Missouri. As an avid alumnus of Iowa State University, he twirled the baton leading the Cyclone Alumni band. He was a member of Shriners International, NSPE, and was a model train enthusiast.
